CONSUMER AFFAIRS AUTHORITY ACT, No. 09 OF 2003

Special Direction under Section 10(1)(b)(ii)

ACTING under the powers vested in it by Section 10(1)(b)(ii) of the Consumer Affairs Authority Act, No. 09 of 2003, The Consumer Affairs Authority directs all Transporters, Distributors and Traders of locally produced vegetables and fruits listed below, that they shall use containers made out of plastic, hard paper or wood when collecting, storing, transporting of such locally produced vegetables and fruits.
