**CONSUMER AFFAIRS AUTHORITY ACT, No. 09 OF 2003**

**Order under Section 20(5)**

ACTING under the powers vested in it by Section 20(5) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority orders that no producer, trader or distributor shall sell, expose or offer for sale, display for sale the following item, above the Maximum Retail Price specified hereunder :

*Maximum Retail Price*

Frozen or chilled Broiler Chicken Meat (whole chicken) without skin      Rs. 480/- per kg

This Order shall come into effect from 10th December 2015.

**CONSUMER AFFAIRS AUTHORITY ACT, No. 09 OF 2003**

**Order under Section 20(5)**

ACTING under the powers vested in it by Section 20(5) of the Consumer Affairs Authority Act, No. 09 of 2003, the Consumer Affairs Authority by Order No. 35 published in *Gazette Extraordinary* No. 1942/14 dated 24th November 2015 the following Maximum Retail Prices were introduced in respect of the items listed below :

<i>Product</i>	<i>Maximum Retail Price</i>
Dried Sprats	Rs. 410/- per kg (Un Packetted)
Dhal	Rs. 169/- per kg (Un Packetted)
Dried Fish "Katta"	Rs. 1,100/- per kg (Un Packetted)
Dried Fish "Salaya"	Rs. 425/- per kg (Un Packetted)
Chickpeas	Rs. 169/- per kg (Un Packetted)

The Consumer Affairs Authority acting under the powers vested in it by Section 20(5) of the said Act, orders that manufacturers, importers, packers, distributors or traders of the above items may add a further sum not exceeding Rs. 5/- per pack/packet irrespective of the weight, if the items listed above are offered for sale, exposed/displayed for sale in packs/packets.

This Order shall come into effect from 10th December, 2015.
